NORM Report - Nick Natale

Successful meeting w/ 12,800 in profit from the meeting. Only outstanding expense is the repayment of a \$3K loan from NOR board. Discussion over how to handle repayment. Nick proposed two approaches

- 1) Repay loan from profit and the remainder will be split 60:40 between MT section and NOR
- 2) Use MT section funds to repay the loan, and split the \$12,800 60:40 between MT section and NOR. This approach would show a higher profit on paper for the Meeting.

Approach 1 provides a ~\$1,200 higher return to the MT section and was adopted.

Tony H. reported on the NORM Small Business Symposium (Tony and Tyler organizers). Tony was successful in landing a \$2,500 Innovative Program Grant from ACS

Councilor's Report – Tony Haag

Discussion on the American Association of Chemistry Teachers (AACT), a new organization within ACS unveiled during the National Fall meeting. Membership dues are \$50 per year which makes key ACS education resources more accessible for high school teachers.

Motion was made to make awards monetary rather than travel grants. Motion was not adopted because we want to continue to encourage students to attend and present at larger meetings

3 positions are opening up, Chair Elect, Treasurer and Secretary, all 2 year positions. Nominations were made.

Discussion around electronic ballots. Changeover needs to be approved by the entire section, not just executive board.

2015 Spring Meeting Planning

- Contact ACS for a list of Montana High Schools with Chemistry Clubs **Jesse** (*Note: See above. How will we use this info?*)
- Confirm dates for MAS annual meeting and MSU undergrad symposium to guide Spring Meeting scheduling – Jesse
- Select Spring meeting date and location by end of December Carol
- Line-up keynote speaker for Spring meeting Carol

 Include measure on 2014 board election ballot proposing a move to electronic voting for the Montana section – Tyler

Resolutions:

- Voted to use \$3,000 of NORM profit to pay back NOR board loan. The remainder of the profit (~\$9,800) will be split 60/40 between MT Local Section and NOR Section
- Approval to spend \$1,500 for National Chemistry Week outreach brochures for high schools (Nick Natale will coordinate)
- Approval to spend \$500 to sponsor 10 American Association of Chemistry Teachers memberships for Montana high school teachers
- Approval to send incoming Chair and Chair Elect to ACS Leadership Institute
- Approval to sponsor a MT ACS Section booth at the 2015 Montana Science Teachers Association Expo (Carol will coordinate)
